“21.2 Notwithstanding any information contained on FAW COMET, or the ability of any User, Member, Club or Subordinate to undertake any action or process on FAW COMET, the provisions of the FAW Rules and Regulations ultimately prevail, and it is the responsibility of any User, Member, Club or Subordinate to comply with any such provision.
